See also Pursuit References Category:RunningPaul Manafort will take a different plea deal with special counsel Robert Mueller in the Russia investigation: No prison time, an individual familiar with the matter told NBC News. Mueller's team filed a memo to the judge that Manafort, President Donald Trump's former campaign chairman, would be willing to accept a 30-day sentence of house arrest, the person said, as long as he cooperates with the probe. U.S. District Judge Amy Berman Jackson scheduled a hearing for Tuesday in the case in which she will consider the deal. The memo from Mueller's team to Judge Jackson appears to be an effort to relieve the government of having to secure a superseding indictment against Manafort, a person familiar with the case told NBC News. The person spoke on condition of anonymity because they weren't authorized to discuss the matter publicly. Manafort's lawyers say the 78-year-old is in poor health, suffered a stroke in March and is suffering from dementia. A plea deal, they say, will expedite his trial on a bank fraud charge he faces in Virginia. Manafort has been under house arrest since his detention in July after being indicted on a slew of federal charges including bank and tax fraud. He's agreed to cooperate with the probe and court proceedings are proceeding along as expected, the person familiar with the case said. Special counsel Robert Mueller filed a memo to a federal judge in the Paul Manafort case asking that he be allowed to testify against the

former Trump campaign chairman in a way that would be "admissible at a subsequent trial of either defendant," as NBC News previously reported. In a separate but related case in federal court in Washington, Mueller has charged Manafort with five counts related to tax and bank fraud, including conspiracy against the United States. The two cases are being overseen by Judge Amy Berman Jackson. Manafort has pleaded not guilty to the charges.
