Some pensions specialists have advised clients across a full spectrum of issues; from complex scheme rule amendments and pensions taxation and investment issues; to High Court applications pertaining to construction and rectification of pension scheme rules; through to managing defined benefit pension risks on corporate transactions. A selection of UK tax barristers advise in relation to stamp taxes, including SDLT, and have experience advising on SDLT planning. They assist clients to structure their holdings to as to reduce or eliminate the burden of SDLT in accordance with the law and HMRC guidance. Barristers will usually be instructed to give advice on the law and to speak (termed advocacy) on behalf of the client in the court hearings. However, some solicitors do their own advocacy. During a tax investigation, a tax barrister may help to build a strong defence which gives you the best-possible chance of a successful case. Salary Sacrifice is something that a pensions specialist barrister can provide advice on. Management of closure of final salary or defined benefit pension schemes to future accrual for employers is something that a pensions specialist barrister can provide advice on.



Tax barristers may end up spending their time advising big businesses on how to avoid paying tax without breaking the law. Accomplished tax virtuosos can advise in

dealing with a wide range of tax issues. Seasoned tax barristers advise on tax lawsuits. The skills and experience of a tax barrister cover VAT (both domestic and European issues), customs and excise duties, stamp duties, development land tax, inheritance and business tax reliefs, and issues of residence and domicile. Strong Practise In Tax Litigation

Adept tax barristers regularly act for both the taxpayer and HMRC. They combine specialist tax knowledge from experience of cases in civil and criminal courts with a background of advocacy in criminal courts which brings advantages in any type of hearing. Seasoned tax virtuosos could advise on drafting of documents. Strategic reviews of employer benefit provision is something that a pensions specialist barrister can provide advice on. Individuals and firms should be able to undertake legitimate tax planning. However, where specialist advisers are deployed on unusual and creative schemes, tax planning can be deemed to move beyond legitimate avoidance. The application of scheme funding, employer and member communications as well as liaison with the Pensions Regulator where appropriate is something that a barrister focusing on pensions can assist with. All professionals involved with [Inheritance Tax Advice](#) have a duty to be confidential.

Tax evasion is submitting a tax return that you know to be untrue, either because it excludes income that should have been declared, or because expenses are claimed which are not appropriate for tax purposes. Tax barristers can be instructed by members of the Chartered Institute of Management Accountants without the need for a solicitor as intermediary. A barrister with land and property experience can provide opinions on various aspects of SDLT including MDR claims, pre-completion transactions and incorporations. A barrister focused on tax can advise on tax related criminal investigations and on issues relating to tax professional negligence. SDLT specialist UK tax advisers can provide advice as to how to mitigate your potential liability to Stamp Duty Land Tax, recover overpaid stamp duty, assist in challenging correspondence from HMRC and challenge previous advisers whose advice on SDLT may have been negligent. Good Mix Of Tax Technicians

Tax legislation and the regulatory landscape are evolving within the United States and tax jurisdictions throughout the world - to provide the most value to their clients, tax professionals must understand what changes are occurring and why. The Public Access scheme allows members of the public to instruct a barrister directly. In the past it was necessary to use a solicitor to instruct a barrister. Some barristers accept instructions from businesses or the public directly under this scheme. The majority of cases accepted under the Public Access Scheme are employment cases which are heard in the Employment Tribunal. A barrister with a

tax specialism can offer expert advice on tax issues in non-contentious cases including tax aspects of commercial transactions. Tax barristers can take on cases exclusively concerned with taxation in jurisdictions outside the UK, such as Hong Kong, Ireland or the UK's overseas territories. Some British tax barristers can help with offshore financial centre trust and corporate, hybrid and double taxation planning. Tax barristers practise exclusively in all aspects of direct and indirect tax. Practice in this area requires a thorough knowledge of other areas of the law including: company, trust, contract, land, EU and international law and conflict of laws. In recent years, the UK tax authority, HM Revenue & Customs (HMRC), has become more aggressive in tackling tax avoidance, largely in response to political pressure that it was soft on this issue. This has resulted in a significant growth in UK tax disputes, both in a civil and criminal context. If you are looking to mitigate the rate of tax when you sell or otherwise dispose of assets, or are considering the impact of getting rid of assets on other taxes, a tax barrister can guide you.
